RELEASE AND HOLD HARMLESS AGREEMENT

This Release and Hold Harmless Agreement ("Agreement") is made on this Date:,

Releasor has requested that he/she be allowed to ride and/or work around horses that are owned by the Farm and other individuals, on property owned by DACZ, LLC located at 3307 Startown Road, Newton, North Carolina. The Farm requires that this Agreement be signed as a condition of such use.

In consideration of the privilege to ride and/or work around horses at the Farm, the Releasor does hereby release and forever discharge the Farm, its successors, assigns, officers, agents, employees, individual horse owners and instructors from any and all liability, responsibility, causes of action, or claims which may arise or be in any way connected with the presence of Releasor on the Farm premises and riding and/or working around horses, including but not limited to a claim for injury to his/her person or property and claims by third parties.

Releasor agrees to indemnify and hold the Farm harmless from any loss, damage, liability, or claim arising out of or in any way connected with engagement in an equine activity, as defined by NCGS 99E-1, including those who are visitors and/or spectators, and those who are riding and/or working around horses on the Farm premises.

This Agreement shall be binding upon the Releasor, his or her heirs, successors, and assigns, and shall inure to the benefit of the Farm, its successors, assigns, officers, agents, employees, or instructors. This Agreement shall be governed by and construed according to the laws of the State of North Carolina.

The Releasor hereby assumes the unavoidable risks inherent in all equine related activities, including but not limited to bodily injury and physical harm to rider, spectator and horse.

WARNING

Under North Carolina Law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities. Chapter 99E of the North Carolina General Statutes
